#### INTRODUCTION

On February 6 and 20, 2023, two earthquakes with magnitudes of 7.8 and 6.4 struck Syria and the Turkey-Syria border, respectively, causing widespread destruction and killing over 5,000 people. This has compounded the challenges faced by Syrians due to 12 years of conflict, with already weak infrastructure and buildings being further damaged. The worst affected areas were Aleppo and Idlib in the Northwest. The earthquake has worsened already dire humanitarian conditions in the region, with almost 44% of Syrians severely food insecure and 6.8 million internally displaced persons. The political fragmentation of the region has further complicated relief efforts, with different areas being controlled by the government, opposition, and the Syrian Democratic Forces.

The earthquake has had a significant impact on the food security and housing situation in Syria, exacerbating already challenging conditions. Prior to the earthquake, nearly 9.5 million Syrians were severely food insecure, and an additional 2.5 million were at risk of becoming food insecure. The earthquake has likely made these conditions even worse, especially in the Northwest region.

Moreover, Syria has been facing a complex political situation with a fragmented landscape, which has made it challenging to provide humanitarian assistance to those in need.

The earthquake has compounded the challenges faced by Syrians, as it has caused extensive damage to infrastructure, buildings, and essential services, including hospitals and schools. The destruction of infrastructure has made it difficult to provide critical services and support, especially in the hardest-hit areas of Aleppo and Idlib.

Overall, the earthquake has added to the already dire humanitarian situation in Syria, where millions of people are struggling to access basic needs such as food, water, and shelter. The situation has been further complicated by the political fragmentation of the country, which has made it challenging to coordinate relief efforts and provide support to those in need.



#### **METHODOLOGY**

The Al-Ameen Organization has conducted a rapid needs assessment in an effort to gain a comprehensive understanding of the humanitarian situation in the North West of Syria, specifically in the communities affected by the recent earthquake. This assessment was conducted across all major humanitarian sectors, including displacement, shelter, non-food items (NFIs), food security and livelihood, protection, WASH, education, health, and emergency response. The aim was to examine changes in the needs of the affected population post-earthquake.

The Syrian crisis, now in its twelfth year, has presented immense humanitarian challenges for the country's population, including ongoing conflict, lack of access to basic necessities such as shelter, food, and healthcare, and now the added impact of the earthquake.

The humanitarian situation in Syria changes rapidly and significantly, depending on factors such as conflict intensity, displacement patterns, and access to basic services and aid. The Al-Ameen Organization's report offers a community-level analysis of the humanitarian situation in the North West of Syria, specifically in the communities under the control of the NWS.

Despite the escalation of conflict and deteriorating humanitarian conditions, the North West of Syria has received less international media attention than other governorates experiencing mass displacement. This report seeks to address this gap by providing humanitarian actors with up-to-date information on the current situation in the area.

To ensure an extensive and comprehensive overview of the situation, the Al-Ameen Organization conducted sampling across all sub-districts and communities in the North West of Syria. The data collection was completed through face-to-face interviews with at least five Key Informants (KIs) in each community, totaling 1950 KIs (65% male, 35% female). The KIs included representatives of various civilian bodies such as local council members, teachers, NGO workers, and directors.

The selection of KIs was based on criteria such as their knowledge of the population, local context and situation, professional background, leadership responsibilities, or personal experience, and gender balance. The data analysis plan was based on a sub-district level, with community-level data analysis used for specific questions.

Overall, this report provides a multi-sectoral analysis of the humanitarian situation in the North West of Syria, offering insights into the current needs of the affected communities post-earthquake. The Al-Ameen Organization hopes that this report will help guide humanitarian efforts in the region and raise awareness of the ongoing humanitarian crisis in Syria.



#### LIMITATIONS

The Al-Ameen Organization faced several challenges during the data collection and verification phases of reporting for the Alepp0, Idleb, Lattakia, Hama Governorates, and North West Syria areas, despite having covered most of the communities in those regions. These challenges included restrictions on movement, a low-security situation, and rapid demographic and economic changes, among other factors. However, these difficulties did not affect the quality, time, or scope of data collection or analysis.

One of the limitations that the Al-Ameen Organization encountered during data collection was the lack of accurate information about population numbers, as well as difficulty finding knowledgeable female Key Informants (KIs) in some sectors. To overcome this, the team interviewed multiple KIs for each sector to obtain more accurate information. They also faced challenges in finding KIs with broad knowledge about the relevant sector and community simultaneously.

#### **KEY FINDINGS:**

- The earthquake in North West Syria has affected a significant number of individuals, with an overall estimate of 3.87 million people impacted.
- The governorate of Idleb has been the most heavily affected, with approximately 2.6 million individuals impacted by the earthquake.
- Aleppo has also seen a large number of people impacted, with approximately 1.28 million individuals affected at the governorate level.
- Hama, while not as heavily impacted as the other two governorates, still has a substantial number of individuals affected, with an estimated 1.62 thousand people impacted.
- The severity of the earthquake has also played a role in the number of individuals impacted. Those in areas experiencing an average of six or more damage have been the most heavily impacted, with an average of 3.34 million individuals affected.
- Those in areas experiencing slight damage (around five on the scale) have also been impacted, with an estimated 413.98 thousand individuals affected.
- Areas experiencing major earthquakes (around seven on the scale) have had fewer people impacted, with an estimated 113.08 thousand individuals affected.
- Areas experiencing the most severe earthquakes (around eight on the scale) have had the fewest people impacted, with an estimated 3.1 thousand individuals affected.
- Overall, nearly 57% of communities in North West Syria reported no IDP arrivals, while around 43% reported newly arrived IDPs.
- In Aleppo, around 55% of communities reported no IDP arrivals, while around 45% reported newly arrived IDPs.



- In Idleb, nearly 58% of communities reported no IDP arrivals, while around 42% reported newly arrived IDPs.
- Overall, approximately 36.16 thousand households departed from the community due to the earthquake.
- In Idleb, around 20.64 thousand households departed from the community due to the earthquake, while in Aleppo, approximately 15.53 thousand households departed from the community due to the earthquake.
- the majority of newly displaced households due to earthquake in North West Syria are staying with relatives, while a smaller percentage are residing in functioning tents, makeshift shelters, or collective centers in various types of facilities, including educational and health facilities. The distribution of newly IDP households by shelter type varies by governorate, with a higher percentage of households in Idleb staying in makeshift shelters compared to Aleppo, where more households are staying in functioning tents.
- Shelter assistance is the top priority for just about 24% of communities when it comes to assisting IDP HHs after an earthquake, followed by winterization assistance at nearly 23%, cash assistance at almost 19%, and food assistance at roughly 15%. NFI, nutrition assistance, healthcare assistance, and WASH assistance were identified as priorities by smaller percentages of communities.
- Approximately 49% of newly IDP households in North West Syria have access to food and cooking utensils, while 23% have no access to them, and 21% have access to food but not cooking utensils. Only 6% have access to cooking utensils but not food, and 1% of communities are not sure about their access to these items.
- Newly earthquake IDPs health sector specific needs is that first aid or emergency care is the top priority for approximately 32% of the respondents. This is followed by ambulance services, sexual and reproductive health care, psychiatric care, child health services, chronic illness care, surgery, assistive devices, and diarrhea treatment, in that order of priority. These findings provide important insights for aid organizations and policymakers to prioritize their efforts and resources to address the health needs of the newly earthquake IDPs.
- IDPs WASH sector specific needs in North West Syria is that access to drinking water is the most pressing issue, with nearly 30% of respondents indicating it as a priority. Other important needs identified include sewage systems (17%), waste removal services (10%), disposable diapers (10%), water storage containers (7%), soap (7%), and sanitary pads (7%). A smaller percentage of respondents also mentioned the need for cleaning items (3%), child items (3%), desludging services (3%), and waste bins (3%).



- Top priority winter-specific need for newly earthquake IDPs is heating fuel, with 42% of respondents citing it. Thermal blankets and winter clothes were also mentioned by 32% and 25% of communities, respectively. Only about 1% of communities mentioned a need for winter shoes
- IDPs NFI sector specific needs in North West Syria is that bedding items, sleeping mats, and floor mats are the most important NFI needs for the affected population, with 31%, 23%, and almost 21% of communities respectively mentioning them. Cooking fuel, solar panels, batteries, and cooking utensils are also identified as important needs for a smaller proportion of the population, ranging from 7% to 4% of communities.
- Regarding new collective centers established is that the vast majority of communities in North West Syria (83%) reported that no new collective centers had been established, while only 17% of communities reported the establishment of new collective centers. In Aleppo, 75% of communities reported no new collective centers, while in Hama, all communities reported no new collective centers. This information can be useful for organizations and agencies working on providing assistance to IDPs in the region, as it highlights the limited availability of collective centers as a potential form of shelter for displaced individuals.
- Approximately 44% of the communities reported no damage to residential buildings, while about 31% reported minor damage, 12% reported major damage, 10% reported severe damage, and 4% reported complete destruction.
- In Aleppo governorate, about 36% of communities reported no damage to residential buildings, while around 33% reported minor damage, 14% reported major damage, 13% reported severe damage, and 5% reported complete destruction.
- In Hama governorate, about 75% of communities reported no damage to residential buildings, while around 22% reported minor damage, 2% reported major damage, and 2% reported severe damage.
- The majority of newly displaced households in the target area are staying with relatives as their origin shelter type, followed by residing in functioning tents and staying in vehicles. A smaller percentage of households are staying in damaged buildings, collective centers in other types of facilities, collective centers in educational facilities, and makeshift shelters.
- Households in need of tents and emergency shelter at collective centers is that the overall number of households in need is approximately 75.87K HHs. When broken down by governorate, Idleb has the highest number with approximately 39.76K HHs, followed by Aleppo with close to 36.09K HHs, and Hama with only around 20 HHs.
- When considering earthquake intensity, the results show that at earthquake intensity of six (a lot of damage), the number of households in need of tents and emergency shelter at collective centers is around 52.39K HHs. At earthquake intensity of five (slight damage), the number is approximately 13.32K HHs. For earthquake intensities of seven (major damage) and eight (major earthquake), the numbers are around 10.15K HHs and 10 HHs, respectively.



- Feeding babies challenges is that lack of financial capacity to buy infant formula is the most commonly reported challenge, with almost 30% of communities mentioning it. Other challenges reported include high prices of food items, mothers lacking enough breastmilk, access to infant formula, unavailability of infant formula in the markets, lack of heating mechanism for making infant formula, mothers lacking privacy to breastfeed, infants losing their mother, lack of clean water, children unable to take feed, lack of accessibility to baby formula, and lack of access to feed equipment. These challenges highlight the need for targeted interventions to ensure that babies have access to adequate nutrition, especially in vulnerable communities.
- New challenges for protection due to earthquake in North West Syria is that a significant portion of communities (32%) did not mention any new challenges. However, the most commonly mentioned challenge was the lack of physical safety (31%). Other challenges included missing family members (12%), theft or robbery (8%), family separation and unaccompanied children (5%), and access to humanitarian assistance (4%). Movement restrictions and uncertainty were also mentioned as challenges by 4% and 2% of communities, respectively. A small percentage of communities (1%) expressed fear of exposure to mines as a new challenge for protection due to earthquake.
- The majority of communities (about 61%) in North West Syria did not report any damage to the water supply networks. However, about 27% of communities reported minor damage, and 6% reported major damage. This highlights the need for urgent repairs to ensure a consistent and reliable water supply in the region. Additionally, the 4% of communities that reported severe damage and 1% that reported complete destruction require immediate attention to ensure access to safe and clean water.
- The distribution of damage varies across governorates, with Aleppo reporting higher levels of severe and major damage compared to Idleb, where the majority of communities reported no damage. These findings indicate the urgent need for repairing and rehabilitating health facilities in affected areas to ensure access to essential health services for the population.
- Education facilities damage in North West Syria is that the majority of communities, around 57%, reported no damage to education facilities. However, there are still concerns as about 31% of communities reported minor damage, and approximately 12% of communities reported major or severe damage to education facilities. This highlights the need for urgent action to repair and rebuild damaged education facilities to ensure that children have access to safe and secure learning environments.
- Repair or rehabilitation first need in North West Syria is that electricity networks, telecommunication and internet coverage, healthcare facilities, sanitation infrastructure, water supply networks, education facilities, and roads/streets are among the top priorities for repair or rehabilitation according to community feedback. This highlights the importance of addressing basic infrastructure needs to improve the living conditions and well-being of the population in the region.



- The second most important need for repair or rehabilitation in North West Syria is related to telecommunication and internet coverage, education facilities, and sanitation infrastructure. This suggests that addressing these areas could be crucial for improving the overall situation in the region.
- Health priorities in North West Syria is that first aid or emergency care is the most frequently mentioned priority, with 29% of communities citing it. Other priorities mentioned include ambulance services (22%), child health services (17%), sexual and reproductive health care (14%), treatment for non-communicable disease or chronic illness (7%), psychiatric care (4%), assistive devices (1%), rehabilitation (1%), and surgery (1%). Overall, these results highlight the urgent need for comprehensive and accessible healthcare services in the region.
- WASH priority in North West Syria is that drinking water is the top priority, with 32% of communities identifying it as the most important. Other top priorities include functioning sewage systems (21%), water storage containers (10%), and waste removal services (10%). Additionally, household cleaning items, desludging services, and disposable diapers were identified as important priorities by a significant percentage of communities. The findings highlight the urgent need for improvements in water and sanitation infrastructure in the region.
- Search and rescue operations needs in North West Syria is that the provision of equipment and machinery is the top priority, with 44% of respondents citing it as a need. Additionally, 25% of communities identified the need for additional response teams, 19% identified the need for fuel for operations, and 12% identified the need for additional financial support.
- Types of assistance provided is that food support provision is the most common type of assistance, with 31% of communities indicating it as a form of assistance provided. Other common types of assistance include nutrition support (16%), debris removal (12%), and NFI provision (10%). Shelter support, winterization support, and healthcare support were also mentioned by a significant number of communities. Only a small percentage of communities mentioned cash and infrastructural repairs or rehabilitation as types of assistance provided.
- The majority of communities (61%) did not report any access barriers for humanitarian actors, but weather conditions (13%), road damage (12%), insecurity (11%), and terrain (3%) were reported as the main access barriers.





Figure 1 :AFFECTED POPULATION BY EARTHQUAKE BY EARTHQUAKE INTENSITY

On the other hand, regarding affected population by earthquake at governorate, at Idleb about 2.6M individuals, at Aleppo on the verge of 1.28M individuals affected population by earthquake at governorate, in talking about Hama on the point of 1.62K individuals.

In moving to the results regarding affected population by earthquake at earthquake intensity, while mentioning six a lot of damage on average of 3.34M individuals, at five slight damage almost 413.98K individuals affected population by earthquake at earthquake intensity, at seven major earthquake nigh 113.08K individuals, for eight major earthquake approximately 3.1K individuals.

Also in the same context while talking about communities received IDP due to earthquake at governorate, at Aleppo nearby 55% of communities agree on that no IDP arrived, besides, while mentioning just about 45% of communities had declared that is newly IDP arrival.

Furthermore, when mentioning the communities received IDP due to earthquake at governorate, while mentioning Hama nearby all communities affirmed that no IDP arrived.

Also in the same context while talking about communities received IDP due to earthquake at governorate, at Idleb almost 58% of communities opted that no IDP arrived while mentioning communities received IDP due to earthquake, also to mention that, while mentioning about 42% of communities indicated that is newly IDP arrival.



Furthermore for households departed from community due to earthquake at earthquake intensity, while mentioning six a lot of damage close to 24.44K HHs, in talking about five slight damage close to 8.34K HHs households departed from community due to earthquake at earthquake intensity, at seven major earthquake just about 3.39K HHs, in talking about eight major earthquake on average of 0 HHs.




Figure 4 : NEWLY IDP HHS DUE TO EARTHQUAKE BY EARTHQUAKE INTENSITY




Figure 5 :NEWLY IDP HHS BY SHELTER TYPE BY EARTHQUAKE INTENSITY



In moving to the results regarding after earthquake IDPs HHs priority at governorate, while mentioning Aleppo roughly 26% of communities announced that shelter assistance, moreover while mentioning on the verge of 24% of communities exemplify that is winterization assistance, moreover at on average of 18% of communities pertain with that is cash assistance in mentioning after earthquake IDPs HHs priority, further at on the point of 14% of communities had revealed that is food assistance, in addition to that, in talking about near 8% of communities had cited that is nutrition assistance, moreover while mentioning on the verge of 5% of communities get on well with that is NFI pointing after earthquake IDPs HHs priority, additionally in talking about on the verge of 4% of communities had agreed with that is healthcare assistance, also to mention that, at just about 1% of communities had agreed with that is WASH assistance, as well while mentioning on the point of 0.5% of communities had considered is protection assistance referring to after earthquake IDPs HHs priority.

On the other hand, regarding after earthquake IDPs HHs priority at governorate, while mentioning Idleb close to 23% of communities announced that winterization assistance, and it was found in that in talking about 22% of communities had cited that is shelter assistance, further at approximately 21% of communities indicated that is cash assistance, also to mention that, at on the point of 17% of communities had considered is food assistance, also at about 11% of communities had considered is nutrition assistance, on the other hand for at random 1% of communities told that is wASH assistance, and it was found in that while mentioning almost 1% of communities had considered is healthcare assistance.




Figure 7: NEWLY IDP HOUSEHOLDS ACCESS TO FOOD AND COOKING UTENSILS BY EARTHQUAKE INTENSITY

Based on the previous results and the indicators which results were surveyed in this report, the report paid attention to a topic of newly IDP households access to food and cooking utensils in North West Syria and found according to the statistics that for newly IDP households access to food and cooking utensils at overall nigh 49% indicated that majority have access to food and cooking utensils while pointing to newly IDP households access to food and cooking utensils, besides, in talking about close to 23% of communities opted that is majority have no access to food and cooking utensils, and it was found in that for within sight of 21% of communities affirmed that is majority have access to food while mentioning newly IDP households access to food while mentioning newly IDP households access to food while mentioning newly IDP households access to food and cooking utensils, and it was found in that for within sight of 21% of communities affirmed that is majority have access to food while mentioning newly IDP households access to food and cooking utensils, also the results had shown that at within sight of 1% of communities settled on that is not sure.

While in the same area for newly IDP households access to food and cooking utensils at governorate, while mentioning Aleppo on the verge of 38% of communities stated that majority have access to food and cooking utensils, and it was found in that at close on 29% of communities pertain with that is majority have access to food, in addition to that, at within sight of 28% of communities had revealed that is majority have no access to food and cooking utensils in mentioning newly IDP households access to food and cooking utensils, as well as, in talking about nearby 4% of communities get on well with that is majority have access to cooking utensils, besides, while mentioning about to 2% of communities announced that is not sure.



In moving to the results regarding newly IDP households access to food and cooking utensils at governorate, at Idleb nearby 62% of communities indicated that majority have access to food and cooking utensils, along with that in talking about randomly 18% of communities brought up that is majority have no access to food and cooking utensils, while in the same context while mentioning randomly 12% of communities divulged that is majority have access to food pointing newly IDP households access to food and cooking utensils, while in the same context in talking about nearby 8% of communities had cited that is majority have access to cooking utensils.

Furthermore for newly IDP households access to food and cooking utensils at earthquake intensity, while mentioning eight major earthquake close on 50% of communities explicit that majority have access to food and cooking utensils, furthermore it was found that for about 50% of communities had considered is majority have access to cooking utensils.



While in the same context for newly IDP households access to food and cooking utensils at earthquake intensity, while mentioning six a lot of damage circa 40% of communities had cited that majority have access to food and cooking utensils, along with that at on the verge of 27% of communities stated that is majority have access to food, also to mention that, in talking about on the verge of 25% of communities divulged that is majority have no access to food and cooking utensils, along with that at about to 6% of communities had agreed with that is majority have access to cooking utensils, as well in talking about nearby 2% of communities get on well with that is not sure.

In paying attention in this report to the Newly earthquake IDPs health sector specific needs the statistics found that newly earthquake IDPs health sector specific needs at overall circa 32% had agreed with that first aid or emergency care while mentioning newly earthquake IDPs health sector specific needs, moreover in talking about close to 21% of communities had agreed with that is ambulance services, also the results had shown that for nearby 14% of communities agree on that is sexual and reproductive health care while pointing to newly earthquake IDPs health sector specific needs, and it was found in that at about to 10% of communities pertain with that is psychiatric care, while in the same context in talking about near 6% of communities had revealed that is child health services, further for randomly 6% of communities agree on that is chronic illness in talking about newly earthquake IDPs health sector specific needs, moreover while mentioning near 5% of communities exemplify that is surgery, additionally for close on 4% of communities had declared that is assistive devices, and it was found in that for on average of 2% of communities indicated that is diarrhea treatment pointing newly earthquake IDPs health sector specific needs.



Additionally newly earthquake IDPs health sector specific needs at earthquake intensity, at six a lot of damage at random 30% of communities told that first aid or emergency care, additionally at circa 17% of communities indicated that is ambulance services, and it was found in that while mentioning just about 17% of communities pertain with that is sexual and reproductive health care, furthermore it was found that at about to 9% of communities told that is surgery, besides, while mentioning on average of 9% of communities had cited that is child health services, also to mention that, at circa 6% of communities indicated that is assistive devices, also for on the point of 6% of communities opted that is chronic illness, as well as, in talking about close to 4% of communities pertain with that is psychiatric care, moreover for nigh 2% of communities had revealed that is diarrhea treatment.

that is water storage containers, also to mention that, for about 7% of communities told that is soap referring to newly earthquake IDPs WASH sector specific needs, as well as, while mentioning about 7% of communities pertain with that is sanitary pads, additionally at about to 3% of communities exemplify that is cleaning items, further for about 3% of communities had declared that is child items while mentioning newly earthquake IDPs WASH sector specific needs, besides, at nigh 3% of communities exemplify that is desludging services, along with that for approximately 3% of communities exemplify that is waste bins.

While in the same area for newly earthquake IDPs WASH sector specific needs at governorate, for Aleppo about 43% of communities announced that drinking water, additionally while mentioning near 29% of communities explicit that is sewage system, in addition to that, in talking about to 21% of communities had considered is waste removal services in mentioning newly earthquake IDPs WASH sector specific needs, while in the same context for nigh 7% of communities agree on that is water storage containers.







While in talking about households movements intentions at governorate, in talking about Aleppo close to 73% of communities had considered stay, furthermore it was found that at nigh 13% of communities had cited that is not decided, furthermore it was found that at close to 8% of communities get on well with that is within one week linkage with households movements intentions, furthermore it was found that while mentioning roughly 7% of communities agree on that is in two weeks.

While in the same context for households movements intentions at governorate, for Hama nearby all communities opted that stay while mentioning households movements intentions.

While in the same area for households movements intentions at governorate, at Idleb nearby 71% of communities meet with that stay, additionally while mentioning about to 21% of communities had agreed with that is not decided referring to households movements intentions, and it was found in that while mentioning close to 6% of communities stated that is within one week, furthermore, while mentioning at random 3% of communities pertain with that is in two weeks.

Moreover regarding households movements intentions at earthquake intensity, while mentioning six a lot of damage on the point of 72% of communities had agreed with that stay, moreover in talking about at random 17% of communities indicated that is not decided, additionally at almost 6% of communities announced that is within one week, along with that while mentioning just about 5% of communities opted that is in two weeks.








Figure 13: NEW COLLECTIVE CENTRES ESTABLISHED BY EARTHQUAKE INTENSITY



The main results was found in this report regarding residential buildings destroyed, it was found that in talking residential buildings destroyed at overall roughly 44% pertain with that no damage in talking about residential buildings destroyed, additionally while mentioning close on 31% of communities told that is minor damage, as well as, while mentioning about to 12% of communities indicated that is major damage in mentioning residential buildings destroyed, moreover at roughly 10% of communities had revealed that is severe damage, also to mention that, in talking about at random 4% of communities indicated that is completely destroyed.



In addition to that for residential buildings destroyed at governorate, for Aleppo on the verge of 36% of communities meet with that no damage, along with that at on average of 33% of communities had declared that is minor damage, also while mentioning just about 14% of communities opted that is major damage pointing to residential buildings destroyed, furthermore, for about 13% of communities get on well with that is severe damage, besides, at near 5% of communities meet with that is completely destroyed.

While to mention residential buildings destroyed at governorate, while mentioning Hama almost 75% of communities had agreed with that no damage, also at the same level it was found that while mentioning just about 22% of communities meet with that is minor damage, and it was found in that at nearby 2% of communities get on well with that is major damage pointing to residential buildings destroyed, also the results had shown that at on the point of 2% of communities had agreed with that is severe damage.

Furthermore for residential buildings destroyed at governorate, in talking about Idleb circa 54% of communities divulged that no damage, and it was found in that while mentioning near 28% of communities pertain with that is minor damage, in addition to that, at almost 8% of communities brought up that is major damage, on the other hand for randomly 7% of communities explicit that is severe damage, furthermore it was found that in talking about approximately 3% of communities had revealed that is completely destroyed.

Furthermore, when mentioning the residential buildings destroyed at earthquake intensity, for eight major earthquake close to 85% of communities had agreed with that no damage, along with that in talking about on the verge of 15% of communities had cited that is minor damage.

In addition residential buildings destroyed at earthquake intensity, in talking about five slight damage close to 62% of communities had declared that in o damage, further for just about 26% of communities had cited that is minor damage, as well as, at about 6% of communities announced that is major damage when mentioning residential buildings destroyed, moreover in talking about close on 4% of communities had revealed that is severe damage, as well as, in talking about to 1% of communities affirmed that is completely destroyed.

Additionally residential buildings destroyed at earthquake intensity, at seven major earthquake on average of 32% of communities had agreed with that minor damage, moreover while mentioning nigh 31% of communities meet with that is no damage, furthermore, at on the point of 15% of communities exemplify that is severe damage, in addition to that, while mentioning just about 15% of communities pertain with that is major damage, in addition to that, for nearby 7% of communities exemplify that is completely destroyed.



While in the same context for residential buildings destroyed at earthquake intensity, for six a lot of damage on average of 40% of communities brought up that no damage, further while mentioning on average of 32% of communities opted that is minor damage, also the results had shown that while mentioning almost 13% of communities exemplify that is major damage, as well while mentioning randomly 11% of communities settled on that is severe damage, while in the same context while mentioning on the verge of 4% of communities meet with that is completely destroyed.




Figure 15: NUMBER OF HOUSEHOLDS STAYED IN SHELTERS DESPITE THE STRUCTURE DAMAGE BY EARTHQUAKE INTENSITY





Figure 16: HOUSEHOLDS THAT WERE LIVING IN THE COMMUNITY AT THE TIME OF THE EARTHQUAKE HAVE BEEN DISPLACED FROM THEIR ORIGINAL SHELTERS AS A RESULT OF THE EARTHQUAKE BY EARTHQUAKE INTENSITY

Also in the same context while talking about newly IDP households origin shelter type at earthquake intensity, in talking about five slight damage circa 64% of communities announced that relatives while mentioning newly IDP households origin shelter type, as well as, for on the point of 18% of communities stated that is residing in functioning tents , as well as, for on the point of 11% of communities settled on that is damaged buildings , as well while mentioning on the point of 6% of communities had revealed that is staying in vehicles linkage with newly IDP households origin shelter type, while in the same context at about to 1% of communities divulged that is collective centers in other types of facilities , further at close to 0.5% of communities explicit that is collective centers in educational facilities , while in the same context for on average of 0.5% of communities opted that is residing in makeshift shelter while mentioning newly IDP households origin shelter type, also at the same level it was found that at on the point of 0.5% of communities had revealed that is collective centers in health facilities.



While in the same area for newly IDP households origin shelter type at earthquake intensity, while mentioning seven major earthquake within sight of 53% of communities opted that relatives , furthermore it was found that while mentioning randomly 21% of communities exemplify that is residing in functioning tents , in addition to that, for approximately 16% of communities divulged that is staying in vehicles , in addition to that, at close to 3% of communities told that is collective centers in other types of facilities , while in the same context at just about 3% of communities divulged that is stated that is residing in makeshift shelter , additionally at near 2% of communities stated that is residing in makeshift shelter , additionally in talking about close to 2% of communities divulged that is damaged buildings , additionally for about 0.5% of communities meet with that is collective centers in health facilities.

Moreover regarding newly IDP households origin shelter type at earthquake intensity, in talking about six a lot of damage roughly 56% of communities affirmed that relatives , additionally while mentioning near 23% of communities affirmed that is residing in functioning tents,

also at near 9% of communities agree on that is staying in vehicles , also the results had shown that at within sight of 5% of communities exemplify that is damaged buildings , furthermore, while mentioning nigh 3% of communities had considered is collective centers in other types of facilities , also to mention that, at about to 2% of communities indicated that is collective centers in educational facilities , also for about to 2% of communities pertain with that is residing in makeshift shelter , further in talking about at random 0.5% of communities exemplify that is collective centers in health facilities .




Figure 18: HOUSEHOLDS IN NEED OF TENTS AND EMERGENCY SHELTER AT COLLECTIVE CENTRES BY EARTHQUAKE INTENSITY




#### Figure 19: HOUSEHOLDS IN NEED OF MATTRESSES, HIGH THERMAL BLANKETS, AND CLOTHING BY EARTHQUAKE INTENSITY

In paying attention in this report to the households in need of mattresses, high thermal blankets, and clothing the statistics found that households in need of mattresses, high thermal blankets, and clothing at overall, at approximately 124.51K HHs.

Furthermore, when mentioning the households in need of mattresses, high thermal blankets, and clothing at governorate, for Aleppo about to 71.53K HHs, while mentioning Idleb about to 52.96K HHs households in need of mattresses, high thermal blankets, and clothing at governorate, for Hama near 20 HHs.



Also in the same context while talking about households in need of mattresses, high thermal blankets, and clothing at earthquake intensity, for six a lot of damage close on 94.1K HHs, at five slight damage nigh 20.56K HHs households in need of mattresses, high thermal blankets, and clothing at earthquake intensity, while mentioning seven major earthquake circa 9.68K HHs, while mentioning eight major earthquake randomly 185 HHs.

It is worth talking about feeding babies challenges 0 feeding babies challenges at overall close to 30% had considered lack of financial capacity to buy infant formula in mentioning feeding babies challenges, also the results had shown that in talking about 17% of communities had agreed with that is high prices of food items, as well as, for nearby 14% of communities opted that is mothers lack enough breastmilk when mentioning feeding babies challenges, also the results had shown that for about to 8% of communities opted that is no challenges, also at the same level it was found that while mentioning almost 7% of communities settled on that is access to infant formula, also at the same level it was found that for at random 6% of communities had declared that is unavailability in the markets while mentioning feeding babies



challenges, additionally while mentioning near 6% of communities told that is lack of heating mechanism for making infant formula, and it was found in that at approximately 4% of communities brought up that is mothers lack of privacy to breastfeed, while in the same context at near 2% of communities told that is infants lost mother pointing to feeding babies challenges, also at near 2% of communities had agreed with that is lack of clean water, also for near 2% of communities affirmed that is children unable to take feed, and it was found in that for on average of 1% of communities get on well with that is lack of accessibility to baby formula, also the results had shown that in talking about randomly 1% of communities settled on that is lack of access to feed equipment.

On the other hand, regarding feeding babies challenges at governorate, in talking about Aleppo just about 30% of communities had agreed with that lack of financial capacity to buy infant formula, also at the same level it was found that for randomly 19% of communities had cited that is high prices of food items, furthermore it was found that while mentioning on the verge of 13% of communities pertain with that is mothers lack enough breastmilk while mentioning feeding babies challenges, furthermore, in talking about 8% of communities explicit that is access to infant formula, furthermore, for on the verge of 6% of communities had cited that is unavailability in the markets, also to mention that, at roughly 6% of communities brought up that is no challenges while mentioning feeding babies challenges, further at close to 5% of communities had declared that is lack of heating mechanism for making infant formula, besides, for near 4% of communities affirmed that is mothers lack of privacy to breastfeed, besides, while mentioning roughly 2% of communities had revealed that is infants lost mother while mentioning feeding babies challenges, further for near 2% of communities get on well with that is lack of clean water, also to mention that, for roughly 2% of communities had revealed that is children unable to take feed, also to mention that, while mentioning circa 2% of communities settled on that is lack of accessibility to baby formula, also at the same level it was found that for at random 1% of communities told that is lack of access to feed equipment .

5% of communities announced that is access to infant formula, furthermore it was found that in talking about circa 5% of communities brought up that is mothers lack of privacy to breastfeed, as well for close to 2% of communities had revealed that is lack of clean water, along with that while mentioning nigh 2% of communities exemplify that is infants lost mother, also at the same level it was found that in talking about close to 1% of communities pertain with that is children unable to take feed.



Referring to new challenges for protection due to earthquake in this report and especially in North West Syria, the results showed that for new challenges for protection due to earthquake at overall nearby 32% brought up that none referring to new challenges for protection due to earthquake, moreover for randomly 31% of communities had considered is lack of physical safety, also at the same level it was found that while mentioning close to 12% of communities get on well with that is missing family members pointing new challenges for protection due to earthquake, as well as, at within sight of 8% of communities opted that is theft or robbery, besides, while mentioning close on 5% of communities get on well with that is family separation and unaccompanied children, also the results had shown that for close on 4% of communities opted that is access to humanitarian assistance while mentioning new challenges for protection due to earthquake, also to mention that, for nearby 4% of communities explicit that is movement restrictions, moreover for nearby 2% of communities get on well with that is not sure, further in talking about on the verge of 1% of communities announced that is fear of exposure to mines while pointing to new challenges for protection due to earthquake.

Moreover regarding new challenges for protection due to earthquake at governorate, in talking about Aleppo nigh 32% of communities had revealed that none, also at the same level it was found that for randomly 31% of communities brought up that is lack of physical safety, besides, while mentioning just about 12% of communities indicated that is missing family members in talking about new challenges for protection due to earthquake, also at the same level it was found that in talking about 8% of communities had agreed with that is theft or robbery, along with that for at random 5% of communities announced that is family separation and unaccompanied children, besides, for near 5% of communities indicated that is access to humanitarian assistance while mentioning new challenges for protection due to earthquake, additionally at almost 4% of communities stated that is not sure , as well as, while mentioning close to 1% of communities settled on that is fear of exposure to mines pointing to new challenges for protection due to earthquake.

In addition new challenges for protection due to earthquake at earthquake intensity, at seven major earthquake roughly 37% of communities opted that lack of physical safety, in addition to that, for within sight of 25% of communities had revealed that is none, additionally while mentioning on average of 12% of communities pertain with that is missing family members in talking about new challenges for protection due to

earthquake, besides, in talking about to 10% of communities opted that is theft or robbery, on the other hand while mentioning nearby 4% of communities told that is movement restrictions, on the other hand for at random 3% of communities had cited that is not sure referring to new challenges for protection due to earthquake, further for close to 3% of communities had cited that is access to humanitarian assistance, also at about 3% of communities had cited that for almost 2% of communities had revealed that is family separation and unaccompanied children.

In addition to that for new challenges for protection due to earthquake at earthquake intensity, for six a lot of damage close on 34% of communities had revealed that none, further for on average of 28% of communities opted that is lack of physical safety, additionally in talking about 12% of communities brought up that is missing family members, furthermore it was found that at on average of 8% of communities had cited that is theft or robbery, furthermore, for within sight of 6% of communities opted that is family separation and unaccompanied children, furthermore, while mentioning on average of 5% of communities divulged that is access to humanitarian assistance, as well as, at near 4% of communities indicated that is movement restrictions, and it was found in that in talking about almost 2% of communities divulged that is not sure , on the other hand for roughly 1% of communities had agreed with that is fear of exposure to mines.




Figure 22: ELECTRICITY NETWORK CONDITION BY EARTHQUAKE INTENSITY

Also in the same context while talking about electricity network condition at governorate, at Aleppo approximately 37% of communities had revealed that not applicable, in addition to that, in talking about 32% of communities get on well with that is minor damage, in addition to that, for almost 14% of communities opted that is no damage while pointing to electricity network condition, moreover in talking about near 7% of communities indicated that is severe damage, and it was found in that in talking about nearby 6% of communities had considered is major damage, as well as, for close on 3% of communities agree on that is completely destroyed while pointing to electricity network condition.

Furthermore for electricity network condition at governorate, while mentioning Hama close to 60% of communities pertain with that not applicable, on the other hand at nearby 40% of communities had cited that is no damage in talking about electricity network condition.

Also in the same context while talking about electricity network condition at governorate, while mentioning Idleb about 72% of communities announced that not applicable, while in the same context while mentioning on average of 10% of communities brought up that is no damage, as well as, for on the verge of 10% of communities meet with that is minor damage, additionally in talking about within sight of 4% of communities opted that is major damage, in addition to that, for about to 3% of communities opted that is severe damage, and it was found in that at close on 2% of communities had revealed that is completely destroyed.

Also in the same context while talking about electricity network condition at earthquake intensity, while mentioning five slight damage approximately 82% of communities opted that not applicable pointing out to electricity network condition, while in the same context while mentioning roughly 8% of communities get on well with that is minor damage, further at near 7% of communities told that is no damage, and it was found in that at near 2% of communities opted that is completely destroyed while pointing to electricity network condition, also the results had shown that for within sight of 2% of communities settled on that is major damage, as well as, at within sight of 1% of communities affirmed that is severe damage.

In addition to that for electricity network condition at earthquake intensity, while mentioning seven major earthquake about to 37% of communities indicated that not applicable, in addition to that, while mentioning nigh 26% of communities get on well with that is minor damage, while in the same context at within sight of 12% of communities stated that is severe damage, also in talking about 11% of communities brought up that is no damage, furthermore, while mentioning roughly 7% of communities agree on that is completely destroyed, and it was found in that at approximately 7% of communities indicated that is major damage.




Figure 23: WATER SUPPLY NETWORKS CONDITION BY EARTHQUAKE INTENSITY

Also in the same context while talking about water supply networks condition at governorate, for Aleppo circa 31% of communities stated that minor damage, furthermore, while mentioning almost 30% of communities stated that is no damage, furthermore, while mentioning near 26% of communities had cited that is not applicable in mentioning water supply networks condition, also to mention that, in talking about approximately 7% of communities agree on that is major damage, also the results had shown that at roughly 5% of communities settled on that is severe damage, besides, while mentioning about to 1% of communities agree on that is completely destroyed when mentioning water supply networks condition.

In addition water supply networks condition at governorate, at Hama nearby all communities had considered no damage.



Based on the previous results and the indicators which results were surveyed in this report, the report paid attention to a topic of Sanitation networks condition in North West Syria and found according to the statistics that for sanitation networks condition at overall just about 38% get on well with that not applicable referring to sanitation networks condition, furthermore it was found that for circa 31% of communities had revealed that is no damage, besides, in talking about near 21% of communities announced that is minor damage referring to sanitation networks condition, furthermore, in talking about roughly 6% of communities had cited that is major damage, also the results had shown that at near 4% of communities exemplify that is severe damage, furthermore it was found that while mentioning close to 1% of communities pertain with that is completely destroyed in talking about sanitation networks condition.

In moving to the results regarding sanitation networks condition at governorate, for Aleppo almost 36% of communities exemplify that not applicable, and it was found in that at near 28% of communities had agreed with that is no damage, also in talking about nearby 24% of communities stated that is minor damage referring to sanitation networks condition, additionally at nigh 6% of communities had agreed with that is major damage, and it was found in that while mentioning close on 6% of communities opted that is severe damage, as well while mentioning at random 1% of communities had considered is completely destroyed indicating sanitation networks condition.

While in talking about sanitation networks condition at governorate, in talking about Hama nigh 60% of communities had revealed that no damage, also the results had shown that at randomly 40% of communities had considered is not applicable pointing sanitation networks condition.

Moreover regarding sanitation networks condition at governorate, at Idleb about to 41% of communities divulged that not applicable, moreover in talking about roughly 35% of communities pertain with that is no damage, and it was found in that at about to 17% of communities had revealed that is minor damage, also to mention that, at about to 5% of communities stated that is major damage, moreover for about 1% of communities settled on that is completely destroyed, furthermore, for just about 0.5% of communities divulged that is severe damage.




Figure 25: TELECOMMUNICATION AND INTERNET NETWORKS CONDITION BY EARTHQUAKE INTENSITY



One of the points that we should mention in this report is to talk about the Telecommunication and internet networks condition in North West Syria, while the results in this report had shown that in talking about telecommunication and internet networks condition at overall at random 50% brought up that minor damage linkage with telecommunication and internet networks condition, also for nearby 26% of communities agree on that is no damage, in addition to that, for nearby 16% of communities get on well with that is major damage when mentioning telecommunication and internet networks condition, also to mention that, in talking about 5% of communities told that is severe damage, as well as, while mentioning nigh 3% of communities affirmed that is completely destroyed, on the other hand while mentioning at random 1% of communities settled on that is not applicable in mentioning telecommunication and internet networks condition.

On the other hand, regarding telecommunication and internet networks condition at governorate, for Aleppo close to 45% of communities had cited that minor damage, along with that at within sight of 29% of communities settled on that is no damage, along with that in talking about nearby 19% of communities exemplify that is major damage pointing out to telecommunication and internet networks condition, also the results had shown that for on the verge of 5% of communities exemplify that is severe damage, as well in talking about on the point of 1% of communities told that is not applicable, along with that in talking about on the point of 1% of communities had not internet networks condition.

Furthermore for telecommunication and internet networks condition at governorate, at Hama on average of all communities indicated that major damage.

Also in the same context while talking about telecommunication and internet networks condition at governorate, for Idleb circa 58% of communities agree on that minor damage, in addition to that, for close on 23% of communities had agreed with that is no damage, furthermore, in talking about nearby 10% of communities brought up that is major damage, moreover at randomly 5% of communities stated that is completely destroyed, further for at random 4% of communities stated that is severe damage.


Additionally telecommunication and internet networks condition at earthquake intensity, at eight major earthquake circa all communities get on well with that minor damage.

In moving to the results regarding telecommunication and internet networks condition at earthquake intensity, at five slight damage on the point of 56% of communities brought up that minor damage linkage with telecommunication and internet networks condition, in addition to that, in talking about nearby 28% of communities pertain with that is no damage, as well for on the verge of 9% of communities agree on that is major damage, also the results had shown that at near 4% of communities exemplify that is severe damage when mentioning telecommunication and internet networks condition, additionally while mentioning on the point of 3% of communities had considered is completely destroyed.



In addition to that for telecommunication and internet networks condition at earthquake intensity, in talking about seven major earthquake on average of 37% of communities pertain with that minor damage referring to telecommunication and internet networks condition, as well as, in talking about on average of 27% of communities had revealed that is no damage, moreover at about to 24% of communities brought up that is major damage, also the results had shown that for near 7% of communities explicit that is severe damage, along with that at about 2% of communities told that is completely destroyed, furthermore it was found that while mentioning nearby 2% of communities agree on that is not applicable.

Also in the same context while talking about telecommunication and internet networks condition at earthquake intensity, while mentioning six a lot of damage near 51% of communities had declared that minor damage, on the other hand for on average of 26% of communities explicit that is no damage, as well while mentioning randomly 16% of communities opted that is major damage, besides, while mentioning at random 5% of communities affirmed that is severe damage, furthermore, while mentioning on the verge of 2% of communities brought up that is completely destroyed, further while mentioning close on 1% of communities divulged that is not applicable.

While in talking about health facilities damage at governorate, at Aleppo almost 45% of communities opted that no damage, also to mention that, in talking about nearby 35% of communities had declared that is minor damage, also in talking about close to 10% of communities affirmed that is severe damage referring to health facilities damage, furthermore, at close on 8% of communities exemplify that is major damage, besides, at approximately 2% of communities settled on that is completely destroyed.

While in the same area for health facilities damage at governorate, for Idleb within sight of 60% of communities announced that no damage, in addition to that, for nigh 34% of communities brought up that is minor damage, also at the same level it was found that in talking about randomly 5% of communities stated that is major damage pointing out to health facilities damage, along with that while mentioning approximately 2% of communities exemplify that is severe damage.

Additionally health facilities damage at earthquake intensity, while mentioning five slight damage near 66% of communities told that no damage, in addition to that, for within sight of 26% of communities meet with that is minor damage, also at the same level it was found that for nearby 5% of communities had cited that is severe damage in talking about health facilities damage, as well as, in talking about almost 3% of communities exemplify that is major damage.

Furthermore for health facilities damage at earthquake intensity, at seven major earthquake about to 43% of communities settled on that no damage in mentioning health facilities damage, additionally while mentioning on average of 25% of communities affirmed that is minor damage, in addition to that, while mentioning almost 21% of communities divulged that is severe damage , while in the same context for about to 9% of communities agree on that is major damage linkage with health facilities damage, also for just about 2% of communities announced that is completely destroyed.

Additionally health facilities damage at earthquake intensity, while mentioning six a lot of damage nearby 50% of communities pertain with that no damage, furthermore it was found that while mentioning nearby 37% of communities meet with that is minor damage, also at the same level it was found that while mentioning close on 7% of communities settled on that is major damage, furthermore it was found that for on the point of 5% of communities get on well with that is severe damage , as well for near 1% of communities divulged that is completely destroyed.




Figure 27: EDUCATION FACILITIES DAMAGE BY EARTHQUAKE INTENSITY

Based on the indicators that were monitored for the preparation of the report, it was necessary to mention and talk about Education facilities damage in North West Syria, and the report had shown regarding education facilities damage at overall roughly 57% exemplify that no damage pointing education facilities damage, furthermore it was found that while mentioning just about 31% of communities pertain with that is minor damage , also the results had shown that in talking about circa 7% of communities brought up that is major damage in talking about education facilities damage, additionally in talking about nearby 4% of communities pertain with that is severe damage , as well as, at nigh 1% of communities brought up that is destroyed completely.



While to mention education facilities damage at governorate, while mentioning Aleppo on the point of 52% of communities had cited that no damage, further at almost 32% of communities had cited that is minor damage, as well for circa 9% of communities affirmed that is major damage in talking about education facilities damage, as well as, while mentioning at random 6% of communities had declared that is severe damage, while in the same context while mentioning approximately 1% of communities explicit that is destroyed completely.

Furthermore, when mentioning the education facilities damage at governorate, for Hama on average of 91% of communities explicit that no damage, moreover in talking about 9% of communities meet with that is minor damage.

Furthermore, when mentioning the education facilities damage at governorate, in talking about Idleb almost 65% of communities affirmed that no damage, additionally while mentioning on average of 29% of communities pertain with that is minor damage, on the other hand at randomly 5% of communities opted that is major damage, additionally in talking about near 1% of communities get on well with that is severe damage, and it was found in that while mentioning about to 1% of communities agree on that is destroyed completely.

Also in the same context while talking about education facilities damage at earthquake intensity, while mentioning eight major earthquake on the verge of all communities had cited that no damage .

On the other hand, regarding education facilities damage at earthquake intensity, in talking about five slight damage circa 74% of communities explicit that no damage linkage with education facilities damage, besides, for just about 21% of communities get on well with that is minor damage , furthermore it was found that while mentioning nigh 5% of communities had agreed with that is major damage , furthermore, at about 0.5% of communities told that is severe damage in talking about education facilities damage.













In addition to that for electricity accessibility at governorate, for Hama nearby all communities indicated that not accessible in mentioning electricity accessibility.

While in the same area for electricity accessibility at governorate, for Idleb randomly 39% of communities meet with that not accessible, in addition to that, while mentioning circa 27% of communities told that is fully accessible in talking about electricity accessibility, as well as, at about 27% of communities exemplify that is partially accessible, while in the same context for on average of 7% of communities get on well with that is not sure.

In the meantime for electricity accessibility at earthquake intensity, in talking about eight major earthquake nigh all communities affirmed that fully accessible.



In addition markets or shops accessibility at governorate, for Aleppo almost 55% of communities had cited that partially accessible, also the results had shown that in talking about at random 38% of communities had cited that is fully accessible, also to mention that, for just about 6% of communities had agreed with that is not accessible indicating markets or shops accessibility.

On the other hand, regarding markets or shops accessibility at governorate, in talking about Hama approximately 80% of communities had cited that partially accessible, furthermore, while mentioning circa 20% of communities affirmed that is fully accessible in mentioning markets or shops accessibility.


Furthermore, when mentioning the markets or shops accessibility at earthquake intensity, in talking about five slight damage close on 75% of communities divulged that fully accessible while pointing to markets or shops accessibility, as well as, while mentioning almost 23% of communities pertain with that is partially accessible, also at the same level it was found that while mentioning just about 2% of communities get on well with that is not accessible.

While in the same context for markets or shops accessibility at earthquake intensity, for seven major earthquake nearby 62% of communities settled on that partially accessible, while in the same context at roughly 32% of communities had considered is fully accessible, as well as, at circa 7% of communities announced that is not accessible pointing to markets or shops accessibility.

While in the same area for markets or shops accessibility at earthquake intensity, in talking about six a lot of damage roughly 51% of communities opted that partially accessible, also to mention that, while mentioning on the verge of 44% of communities brought up that is fully accessible, and it was found in that while mentioning nearby 5% of communities had revealed that is not accessible.

While in the same context for markets and shops access impact accessibility at governorate, while mentioning Hama close to all communities had agreed with that partially accessible indicating markets and shops access impact accessibility.

While to mention markets and shops access impact accessibility at governorate, in talking about Idleb roughly all communities opted that partially accessible.

Furthermore for markets and shops access impact accessibility at earthquake intensity, for eight major earthquake on the point of all communities had agreed with that partially accessible.

Additionally markets and shops access impact accessibility at earthquake intensity, in talking about five slight damage about all communities brought up that partially accessible pointing to markets and shops access impact accessibility.

Also in the same context while talking about markets and shops access impact accessibility at earthquake intensity, at seven major earthquake near all communities exemplify that partially accessible.

Also in the same context while talking about markets and shops access impact accessibility at earthquake intensity, in talking about six a lot of damage within sight of all communities had cited that partially accessible.




Figure 36: WATER SERVICES ACCESSIBILITY BY EARTHQUAKE INTENSITY












Figure 41: REPAIR OR REHABILITATION FIRST NEED BY EARTHQUAKE INTENSITY




Figure 42: SECOND NEED FOR REPAIR OR REHABILITATION BY EARTHQUAKE INTENSITY

In addition second need for repair or rehabilitation at earthquake intensity, while mentioning six a lot of damage on the point of 15% of communities brought up that education facilities, also at the same level it was found that for near 15% of communities had declared that is sanitation infrastructure, while in the same context for close on 13% of communities had revealed that is telecommunication and internet coverage, and it was found in that at about 13% of communities explicit that is water supply networks, while in the same context in talking about nigh 11% of communities indicated that is electricity networks, further while mentioning on the point of 8% of communities affirmed that is roads/streets, also to mention that, in talking about on the point of 8% of communities opted that is healthcare facilities, and it was found in that for about 7% of communities opted that is markets and shops, as well while mentioning close on 5% of communities brought up that is not sure, as well as, for nearby 4% of communities get on well with that is bakeries, also at within sight of 1% of communities stated that is community dug wells, while in the same context while mentioning nearby 1% of communities exemplify that is culverts/piped culverts/small drains, besides, while mentioning within sight of 0.5% of communities had revealed that is bridges.




Figure 43: DEBRIS OR RUBBLE CREATED BY THE EARTHQUAKE NEED TO CLEAN UP BY EARTHQUAKE INTENSITY









In moving to the results regarding specific winterization priority at governorate, in talking about Aleppo just about 47% of communities indicated that heating fuel, furthermore it was found that at randomly 29% of communities affirmed that is thermal blankets, while in the same context in talking about nearby 24% of communities told that is winter clothes while mentioning specific winterization priority, furthermore it was found that for near 1% of communities had considered is winter shoes.

On the other hand, regarding specific winterization priority at governorate, at Hama about 50% of communities agree on that thermal blankets while mentioning specific winterization priority, also to mention that, at close on 50% of communities had declared that is heating fuel.

In moving to the results regarding specific winterization priority at governorate, while mentioning Idleb at random 48% of communities pertain with that heating fuel linkage with specific winterization priority, as well in talking about almost 26% of communities stated that is winter clothes, as well as, while mentioning approximately 25% of communities meet with that is thermal blankets, also to mention that, while mentioning approximately 1% of communities had considered is winter shoes.



Also in the same context while talking about specific winterization priority at earthquake intensity, in talking about eight major earthquake just about 50% of communities divulged that thermal blankets, in addition to that, at circa 50% of communities affirmed that is heating fuel.

Furthermore for specific winterization priority at earthquake intensity, in talking about seven major earthquake about 45% of communities indicated that heating fuel indicating specific winterization priority, furthermore, for approximately 36% of communities opted that is thermal blankets, as well as, for approximately 19% of communities meet with that is winter clothes.

While to mention specific winterization priority at earthquake intensity, while mentioning six a lot of damage randomly 48% of communities opted that heating fuel , also the results had shown that in talking about roughly 26% of communities pertain with that is thermal blankets , besides, while mentioning about 25% of communities pertain with that is winter clothes , in addition to that, for about 1% of communities told that is winter shoes .




Figure 48: SPECIFIC NFI PRIORITY BY EARTHQUAKE INTENSITY

It is worth talking about Specific NFI priority 0 specific NFI priority at overall nearby 27% indicated that bedding items pointing out to specific NFI priority, along with that at roughly 15% of communities meet with that is solar panels, further at near 15% of communities brought up that is floor mats in talking about specific NFI priority, besides, in talking about on average of 13% of communities brought up that is batteries, also at within sight of 11% of communities exemplify that is mattresses or sleeping mats, furthermore, at within sight of 10% of communities stated that is cooking fuel when mentioning specific NFI priority, also while mentioning near 3% of communities had considered is sources of light or solar lamps, furthermore, in talking about near 3% of communities stated that is cooking stoves, along with that at circa 2% of communities indicated that is cooking utensils in mentioning specific NFI priority, and it was found in that for at random 1% of communities meet with that is jerrycans or water containers, also to mention that, at about 1% of communities had considered is plastic sheeting or tarpaulin.



In addition specific NFI priority at governorate, while mentioning Aleppo just about 29% of communities meet with that bedding items , furthermore, at on the verge of 19% of communities had revealed that is floor mats , furthermore, at close to 15% of communities get on well with that is solar panels in mentioning specific NFI priority, also at the same level it was found that while mentioning at random 11% of communities meet with that is batteries , while in the same context at on average of 9% of communities settled on that is mattresses or sleeping mats, besides, for nearby 6% of communities announced that is cooking fuel pointing to specific NFI priority, and it was found in that at almost 5% of communities exemplify that is sources of light or solar lamps, on the other hand while mentioning close to 2% of communities had agreed with that is cooking stoves , besides, at about to 1% of communities settled on that is plastic sheeting or tarpaulin, also the results had shown that while mentioning circa 1% of communities explicit that is jerrycans or water containers.

Furthermore, when mentioning the specific NFI priority at governorate, at Idleb on the verge of 25% of communities agree on that bedding items , further at roughly 15% of communities announced that is solar panels , also at the same level it was found that while mentioning close to 14% of communities had revealed that is cooking fuel , along with that at nearby 14% of communities had agreed with that is batteries , as well as, while mentioning randomly 12% of communities affirmed that is mattresses or sleeping mats, additionally for nigh 10% of communities settled on that is floor mats , also at the same level it was found that for nearby 3% of communities had agreed with that is cooking stoves , furthermore, at nigh 3% of communities had revealed that is cooking utensils , in addition to that, while mentioning nigh 2% of communities stated that is jerrycans or water containers, while in the same context while mentioning randomly 1% of communities explicit that is sources of light or solar lamps, also at the same level it was found that while mentioning on the point of 1% of communities had considered is plastic sheeting or tarpaulin.


While in the same area for specific NFI priority at earthquake intensity, while mentioning five slight damage roughly 25% of communities had cited that bedding items , and it was found in that in talking about 18% of communities get on well with that is batteries , in addition to that, for nearby 14% of communities had cited that is solar panels while mentioning specific NFI priority, in addition to that, in talking about nearby 10% of communities had cited that is floor mats , while in the same context while mentioning at random 10% of communities exemplify that is mattresses or sleeping mats, also to mention that, at just about 10% of communities opted that is cooking fuel when mentioning specific NFI priority, furthermore it was found that at nearby 5% of communities indicated that is cooking stoves , also at the same level it was found that in talking about 3% of communities had revealed that is sources of light or solar lamps, also the results had shown that for about to 3% of communities had revealed that is cooking utensils when mentioning specific NFI priority, on the other hand while mentioning nigh 1% of communities had declared that is jerrycans or water containers.



Moreover regarding specific NFI priority at earthquake intensity, while mentioning seven major earthquake within sight of 31% of communities told that bedding items, along with that in talking about within sight of 16% of communities get on well with that is batteries, while in the same context in talking about at random 16% of communities pertain with that is solar panels, while in the same context while mentioning roughly 16% of communities get on well with that is floor mats, additionally while mentioning randomly 14% of communities announced that is mattresses or sleeping mats, along with that for nearby 4% of communities opted that is sources of light or solar lamps, also to mention that, in talking about approximately 2% of communities get on well with that is jerrycans or water containers, furthermore, for nearby 2% of communities get on well with that is cooking fuel.

While in the same area for specific NFI priority at earthquake intensity, for six a lot of damage about 27% of communities meet with that bedding items , while in the same context while mentioning on the verge of 16% of communities pertain with that is floor mats , furthermore it was found that while mentioning about to 15% of communities opted that is solar panels , as well while mentioning nearby 12% of communities had cited that is cooking fuel , as well for at random 10% of communities settled on that is mattresses or sleeping mats, also at the same level it was found that at about to 10% of communities pertain with that is batteries , besides, at on average of 3% of communities agree on that is sources of light or solar lamps, also the results had shown that in talking about within sight of 2% of communities get on well with that is cooking utensils , furthermore it was found that at close to 1% of communities affirmed that is plastic sheeting or tarpaulin, in addition to that, in talking about randomly 1% of communities get on well with that is jerrycans or water containers.

The report tracked the most important findings when talking about search & rescue operations currently ongoing in North West Syria, while the results had shown in this report found that in talking about search & rescue operations currently ongoing at overall on average of 95% had revealed that no search or rescue operations linkage with search & rescue operations currently ongoing, besides, for nigh 5% of communities agree on that is search & rescue operations taking place.

In addition to that for search & rescue operations currently ongoing at governorate, for Aleppo nearby 94% of communities had considered no search or rescue operations, additionally for nearby 6% of communities had agreed with that is search & rescue operations taking place.

While in the same context for search & rescue operations currently ongoing at governorate, at Hama about all communities brought up that no search or rescue operations.

Furthermore for search & rescue operations currently ongoing at governorate, for Idleb within sight of 95% of communities had cited that no search or rescue operations linkage with search & rescue operations currently ongoing, also for near 5% of communities had agreed with that is search & rescue operations taking place.



In addition search & rescue operations currently ongoing at earthquake intensity, while mentioning eight major earthquake nearby all communities had agreed with that no search or rescue operations.


Furthermore for search & rescue operations currently ongoing at earthquake intensity, in talking about five slight damage about 98% of communities explicit that no search or rescue operations indicating search & rescue operations currently ongoing, along with that in talking about randomly 2% of communities affirmed that is search & rescue operations taking place.

Moreover regarding search & rescue operations currently ongoing at earthquake intensity, in talking about seven major earthquake almost 92% of communities told that no search or rescue operations linkage with search & rescue operations currently ongoing, also in talking about 8% of communities had agreed with that is search & rescue operations taking place.

Also in the same context while talking about search & rescue operations currently ongoing at earthquake intensity, in talking about six a lot of damage about 94% of communities explicit that no search or rescue operations referring to search & rescue operations currently ongoing, and it was found in that while mentioning randomly 6% of communities had agreed with that is search & rescue operations taking place.

Of course, the report did not neglect the reference and examination of the relevant results about search and rescue operations needs in North West Syria, while the results found that for search and rescue operations needs at overall roughly 44% affirmed that provision of equipment and machinery linkage with search and rescue operations needs, also to mention that, for randomly 25% of communities settled on that is additional response teams, further for roughly 19% of communities indicated that is fuel for operations indicating search and rescue operations needs, also at almost 12% of communities had cited that is additional support.

Also in the same context while talking about search and rescue operations needs at governorate, in talking about Aleppo roughly 46% of communities exemplify that provision of equipment and machinery, furthermore it was found that at on the verge of 21% of communities brought up that is fuel for operations, while in the same context for almost 21% of communities pertain with that is additional response teams referring to search and rescue operations needs, while in the same context at nigh 13% of communities affirmed that is additional financial support.



In addition to that for search and rescue operations needs at governorate, in talking about Idleb on the verge of 39% of communities explicit that provision of equipment and machinery while pointing to search and rescue operations needs, while in the same context while mentioning on average of 33% of communities announced that is additional response teams, while in the same context in talking about roughly 17% of communities pertain with that is fuel for operations, besides, while mentioning approximately 11% of communities had agreed with that is additional financial support linkage with search and rescue operations needs.


Also in the same context while talking about search and rescue operations needs at earthquake intensity, for five slight damage on the verge of 40% of communities had revealed that provision of equipment and machinery, as well for nigh 20% of communities get on well with that is fuel for operations, as well as, at on the verge of 20% of communities told that is additional financial support pointing to search and rescue operations needs, furthermore, at about 20% of communities meet with that is additional response teams.

Also in the same context while talking about search and rescue operations needs at earthquake intensity, in talking about seven major earthquake just about 50% of communities brought up that provision of equipment and machinery in talking about search and rescue operations needs, as well as, at close to 29% of communities opted that is fuel for operations, as well while mentioning randomly 14% of communities meet with that is additional financial support, as well as, for within sight of 7% of communities had considered is additional response teams while pointing to search and rescue operations needs.

While in the same area for search and rescue operations needs at earthquake intensity, while mentioning six a lot of damage on average of 42% of communities indicated that provision of equipment and machinery, furthermore it was found that at near 32% of communities pertain with that is additional response teams, also at the same level it was found that at almost 16% of communities had agreed with that is fuel for operations, as well as, while mentioning circa 11% of communities divulged that is additional financial support.

In referring to the target area in this report, it should be noted that with regard to types of assistance provided the report had found that in talking about types of assistance provided at overall close on 31% affirmed that food support provision linkage with types of assistance provided, furthermore, while mentioning randomly 16% of communities had agreed with that is nutrition support, along with that in talking about 12% of communities affirmed that is debris removal in talking about types of assistance provided, as well for close to 10% of communities stated that is NFI provision, moreover while mentioning near 9% of communities had agreed with that is shelter support, further for nearby 8% of communities had declared that is winterization support indicating types of assistance provided, moreover while mentioning randomly 5% of communities had cited that is healthcare support, along with that while mentioning close on 4% of communities affirmed that is WASH support, while in the same context in talking about 2% of communities explicit that is cash referring to types of assistance provided, and it was found in that while mentioning nearby 2% of communities affirmed that is infrastructural repairs or rehabilitation.



Additionally types of assistance provided at governorate, in talking about Aleppo on the verge of 38% of communities announced that food support provision , besides, for near 14% of communities had cited that is nutrition support , in addition to that, for close on 12% of communities announced that is shelter support while pointing to types of assistance provided, additionally while mentioning on the verge of 11% of communities opted that is NFI provision , in addition to that, while mentioning nigh 8% of communities pertain with that is debris removal, also in talking about nearby 5% of communities had agreed with that is winterization support pointing to types of assistance provided, also the results had shown that at nearby 4% of communities get on well with that is WASH support , furthermore, in talking about 4% of communities settled on that is healthcare support , also at the same level it was found that in talking about within sight of 4% of communities pertain with that is cash in talking about types of assistance provided, further for on the point of 1% of communities had agreed with that is infrastructural repairs or rehabilitation.



While to mention types of assistance provided at earthquake intensity, for five slight damage nearby 20% of communities brought up that food support provision , further in talking about circa 20% of communities had agreed with that is nutrition support , in addition to that, for at random 16% of communities divulged that is NFI provision in talking about types of assistance provided, also in talking about to 12% of communities pertain with that is debris removal, also in talking about close to 8% of communities had cited that is WASH support , also while mentioning about types of assistance provided, also communities to 8% of communities had cited that is winterization support in talking about types of assistance provided, moreover for at random 8% of communities stated that is shelter support , along with that in talking about to 4% of communities exemplify that is cash , further in talking about near 4% of communities had cited that is healthcare support while pointing to types of assistance provided.

In addition to that for types of assistance provided at earthquake intensity, for seven major earthquake on the point of 52% of communities settled on that food support provision , as well while mentioning nearby 26% of communities had declared that is nutrition support , while in the same context for within sight of 9% of communities had cited that is debris removal, in addition to that, at about 9% of communities divulged that is NFI provision , also while mentioning on the verge of 4% of communities get on well with that is shelter support .



Furthermore, when mentioning the types of assistance provided at earthquake intensity, at six a lot of damage within sight of 29% of communities exemplify that food support provision , furthermore, while mentioning circa 14% of communities announced that is nutrition support , and it was found in that while mentioning nearby 12% of communities had considered is debris removal, as well as, at on the verge of 10% of communities meet with that is shelter support , furthermore it was found that while mentioning circa 10% of communities divulged that is winterization support , as well as, in talking about to 9% of communities had considered is NFI provision , also the results had shown that for at random 6% of communities had considered is healthcare support , furthermore it was found that at just about 4% of communities meet with that is WASH support , also while mentioning on the verge of 3% of communities told that is infrastructural repairs or rehabilitation.

Based on the previous results and the indicators which results were surveyed in this report, the report paid attention to a topic of post earthquake assistance provider in North West Syria and found according to the statistics that for post earthquake assistance provider at overall about 65% stated that Syrian NGO when mentioning post earthquake assistance provider, also at the same level it was found that in talking about near 19% of communities divulged that is ingo, while in the same context for just about 16% of communities stated that is other while mentioning post earthquake assistance provider.



Also in the same context while talking about post earthquake assistance provider at governorate, while mentioning Aleppo on average of 67% of communities indicated that Syrian NGO, also to mention that, in talking about at random 18% of communities had considered is other, also to mention that, at near 15% of communities had considered is ingo in mentioning post earthquake assistance provider.

While in talking about post earthquake assistance provider at governorate, while mentioning Idleb roughly 62% of communities had agreed with that Syrian NGO, along with that in talking about at random 26% of communities meet with that is ingo referring to post earthquake assistance provider, as well as, in talking about near 12% of communities agree on that is other.

Also in the same context while talking about post earthquake assistance provider at earthquake intensity, while mentioning five slight damage just about 69% of communities meet with that Syrian NGO, furthermore, for near 15% of communities had agreed with that is ingo, while in the same context for on average of 15% of communities told that is other pointing out to post earthquake assistance provider.

While to mention post earthquake assistance provider at earthquake intensity, at seven major earthquake about to 71% of communities had agreed with that Syrian NGO, in addition to that, for about 18% of communities exemplify that is ingo in talking about post earthquake assistance provider, furthermore, at on the point of 12% of communities brought up that is other.

Also in the same context while talking about post earthquake assistance provider at earthquake intensity, in talking about six a lot of damage on the verge of 63% of communities exemplify that Syrian NGO referring to post earthquake assistance provider, also the results had shown that for near 20% of communities had considered is ingo, as well as, at close to 17% of communities exemplify that is other.








Figure 53: HUMANITARIAN ACTORS ACCESS BARRIERS BY EARTHQUAKE INTENSITY

Moving on to review the results and surveys related to Humanitarian actors access barriers in this location, the results in this context and the statistics had shown that for humanitarian actors access barriers at overall nearby 61% indicated that no barriers while pointing to humanitarian actors access barriers, along with that at nigh 13% of communities announced that is weather conditions, also the results had shown that at near 12% of communities get on well with that is road damage pointing out to humanitarian actors access barriers, also the results had shown that for about to 11% of communities brought up that is insecurity affecting the area, while in the same context in talking about to 3% of communities brought up that is terrain.

Furthermore for humanitarian actors access barriers at governorate, for Aleppo near 56% of communities had declared that no barriers, further in talking about near 17% of communities divulged that is weather conditions, furthermore it was found that for approximately 14% of communities agree on that is road damage pointing to humanitarian actors access barriers, also the results had shown that for near 11% of communities indicated that is insecurity affecting the area, also at randomly 3% of communities had considered is terrain.



Furthermore for humanitarian actors access barriers at governorate, while mentioning ldleb at random 71% of communities had considered no barriers, also at the same level it was found that at close on 11% of communities settled on that is insecurity affecting the area, as well as, at on the verge of 9% of communities had considered is road damage in talking about humanitarian actors access barriers, further in talking about 6% of communities had revealed that is weather conditions, as well as, for near 3% of communities explicit that is terrain.

In the meantime for humanitarian actors access barriers at earthquake intensity, at five slight damage circa 85% of communities opted that no barriers, while in the same context at circa 8% of communities brought up that is road damage, moreover at on average of 8% of communities get on well with that is insecurity affecting the area pointing humanitarian actors access barriers.

While in talking about humanitarian actors access barriers at earthquake intensity, in talking about seven major earthquake within sight of 53% of communities had revealed that no barriers, further while mentioning nigh 24% of communities brought up that is road damage pointing to humanitarian actors access barriers, also the results had shown that at randomly 18% of communities settled on that is weather conditions, furthermore it was found that for randomly 6% of communities explicit that is insecurity affecting the area.

While in the same area for humanitarian actors access barriers at earthquake intensity, while mentioning six a lot of damage about 59% of communities divulged that no barriers, furthermore, for at random 14% of communities pertain with that is weather conditions, furthermore it was found that while mentioning randomly 13% of communities indicated that is insecurity affecting the area, further in talking about at random 10% of communities explicit that is road damage, further for roughly 4% of communities meet with that is terrain.



#### **RECOMMENDATION:**

- Providing funding to schools and educational institutions in the target area to improve facilities and resources.
- Offering scholarships and other financial support to children from disadvantaged backgrounds to ensure they have access to education.
- Recruiting and training more teachers to address the shortage of educators in the area.
- Developing and implementing literacy and numeracy programs to improve foundational skills among students.
- Increasing the availability of safe and clean drinking water through the installation of water purification and treatment systems.
- Developing and implementing a comprehensive waste management system to improve sanitation and reduce environmental pollution.
- Providing households with water storage containers to ensure a reliable supply of clean water.
- Investing in waste removal services to improve public health and reduce the spread of diseases.
- Providing education and awareness-raising campaigns about the importance of hygiene and sanitation practices.
- Providing equipment and machinery to enhance search and rescue operations.
- Training and recruiting additional response teams to improve emergency response capacity.
- Ensuring a reliable supply of fuel for operations.
- Offering financial support to organizations involved in search and rescue operations to help cover costs.
- Providing emergency relief and support to communities affected by earthquakes, including shelter, food, and medical assistance.
- Developing and implementing long-term reconstruction and rehabilitation programs to help affected communities rebuild their lives.
- Investing in disaster risk reduction measures to improve preparedness and resilience to future earthquakes.
- Providing food support to address immediate nutritional needs of communities.
- Offering nutrition support to vulnerable populations such as children, pregnant and lactating women, and the elderly.
- Investing in debris removal to help communities recover and rebuild after disasters.
- Providing NFI (non-food items) such as blankets, clothing, and cooking utensils to households in need.
- Offering shelter and winterization support to communities living in areas with harsh weather conditions.
- Investing in healthcare and WASH (water, sanitation, and hygiene) interventions to improve public health outcomes.



- Providing cash assistance to vulnerable households to help them meet their basic needs and support local economies.
- Investing in infrastructural repairs and rehabilitation to improve access to basic services such as education, healthcare, and water and sanitation.
- Addressing road damage and infrastructure challenges to improve access for humanitarian actors.
- Developing and implementing measures to address security concerns and ensure the safety of humanitarian workers and communities.
- Investing in weather-resistant infrastructure to improve the resilience of communities to extreme weather conditions.
- Providing training and resources to humanitarian actors to navigate challenging terrain in the target area.
